CANDIDATE ELIGIBILITY

In order to run for election to the GVR Board of Directors, a candidate must be a GVR Member residing in GVR's jurisdiction or an Assigned Member. A GVR Member is defined as the record holder of legal title to a GVR Property, including a person who holds title in joint tenancy, tenancy in common or as community property. If a property is owned by a trust, the trustee is a GVR member unless otherwise designated in the trust. An Assigned Member is an individual who occupies a GVR Property without paying rent and has been assigned membership rights by the owner(s) of such property. A candidate must be in good standing with GVR at the time of his/her nomination.

I volunteer as a teaching assistant for GVR and non-GVR members to learn the sport of pickleball, as well as volunteer for classes at Quail Creek.

I have regularly attended GVR Board of Director meetings and standing committee meetings.

I volunteer my time to assist friends with learning how to work with mesquite wood, a self taught skill since I became a permanent Green Valley resident.

7. Briefly explain how your education and/or previous career experiences will be beneficial to you as a Director.

As a union Vice-President for Union Local 699, I had the opportunity to gain experience with working with a varied and unique group of people working within the union contract.

I have experience with varied types of community capital maintenance projects as crew leaders, in areas including streets and sewers, asphalt and concrete repair/replacement, sidewalks and related ADA requirements, drainage/sewer infrastructure, bulk waste, refuse, leaf collection, street line painting, street cleaning and snow removal. These experiences gave me the opportunity to come into contact with community citizens expressing their pleasures/complaints and/or concerns on a one-to-one basis and to respond to their comments in a respectful interaction. I have vast understanding of what it takes to provide daily and seasonal functioning of public works and services. I received specialized training in supervision of crews, laborers, equipment, and scheduling.

I have experience working with community leaders including City Council/Alderman, Mayor, City Manager, and Department Heads.

8. What unique personal talents and/or life interests would you bring to the GVR Board of Directors?

Many of my personal talents are in the area of sports, which has taught me about sportsmanship, competition, focus, planning and training. My artistic talent has provided me with pre-planning, preparation and patience.

My union background has taught me to deal with a multiple array of personalities and how to work together and to compromise to achieve a common goal.

9. Describe your use of GVR facilities and participation in GVR activities in the past two years and how your GVR involvement has prepared you to serve on the Board of Directors.

I have used various GVR facilities including the pickleball courts, fitness rooms, swimming pools and spas. I have attended dances, lectures, classes, special events and activities, music events and more. The varied use of GVR facilities and activities has allowed me to gain a knowledge of what GVR has to offer our GVR members and it has helped me to understand the importance of what clubs mean to their individual members and how their club participation creates not only friends but family.
