January 2013 Financial Operations Report



• Year-to-date revenue is \$767,303 - (\$44,550) or 5% under the \$811,853 budget.

The contributing factors to the revenue decrease compared to budget projections:

- \circ $\,$ 65% decrease in miscellaneous income of \$13,502 $\,$
 - Concessions sales, movie contributions, lanyards, copying documents
- \circ $\,$ 64% decrease in guest credit card fees of \$27,204 $\,$
- 13% decrease in capital revenue of \$11,498
- Year-to-date operating expenses are \$876,502 (\$44,644) or 5% under the \$921,146 budget.

- Net operating funds loss for one month of operations as of January 31st is (\$109,199).
- Cash and investment balances at month end were \$8,883,280.
 \$2,482,854, or 28% of this balance, is held for Operating and Replacement Reserves. Non-operating cash is held in short term CDs, money markets and T-bill investments. CD investments are maintained within FDIC limits. Cash forecasts were updated and balanced daily to ensure GVR maintained the appropriate liquidity for operational requirements.
