New Business:

- A. Pilot Program for Clubs/Guests
 - 1. MOTION: Zabicki / Seconded. I move Board Affairs recommend the Board of Directors amend the Corporate Policy Manual Section VIII, Subsection 2, (B)(6) as follows:
 - 6. Clubs may grant guest privileges, at their discretion, to guests of GVR Members—and, if authorized by the Board, other non-GVR Members upon payment of a guest fee to GVR.

 Passed: unanimous
 - 2. MOTION: Zabicki / Seconded. I move Board Affairs Committee recommend GVR Board of Directors authorize the Implementation of a pilot program for Social and Dance Clubs to have non-GVR members attend their dinner and/or dance events.

The pilot program will run from September 1, 2016 to May 31, 2017 to allow non-GVR members to participate in Social and Dance Clubs events for an additional \$4 per person; and the guest must sign a waiver. The club will pay the \$4 fee to GVR and the money will be deposited to the GVR general fund. GVR management will have the right to cancel this pilot program.
