CALL TO ORDER / ESTABLISH QUORUM

Chair Pro Tem Donna Coon called the meeting to order at 1:30 pm. Roll call by Jen Morningstar; quorum established.

<u>AMENDED AND RESTATED GVR BYLAWS</u> – Board Affairs Committee reviewed the "draft" Amended and Restated Bylaws of Green Valley Recreation, Inc.:

Edits:

- Article 1 Definitions 1.8 "GVR Member" shall and refer" Add "mean" after "shall" to read: "GVR Member" shall mean and refer"
- Article 3 Membership and Use of Facilities Add as 3.6 from original Bylaws: Article II Membership Property and Members, Section 6 Voting Rights, B. "It shall be the duty of each GVR Member to keep The Corporation advised of his/her current mailing address."
- Article 6 Board of Directors 6.7, B.3 Add "annual operating and capital" between "Adopting and budgets" to read "Adopting annual operating and capital budgets, which shall include a contribution to reserves."
- Article 7 Board Meetings 7.5.3 Remove "Disciplinary action against a GVR Member."
- Article 7 Board Meetings 7.5.2 Remove "; or " and replace with "."
- Article 9 Committees 9.1.6 Remove "Investment Committee"
- Article 9 Committees 9.1.5 Remove "; and " replace with "."
- Article 9 Committees 9.3 Composition of Committees. Make new paragraph
- Embed live links to each Statute referenced in Bylaws.

2018 Ballot Items:

- Article 7 Board Meetings 7.5.3 Disciplinary action against a GVR Member
- Article 9 Committees 9.1.6 Investment Committee

2019 Ballot Items:

- Article 2 Corporate Jurisdiction 2.2 Expansion of Jurisdiction add "age restriction"
- Article 6 Board of Directors 6.7 Limitations on Powers, A.2 Define "services"
- Article 7 Board Meetings 7.4 Change to more definitive/tighten up with specifics, *i.e.*, "*Until there is a full board, only emergency business can be conducted.*" At the same time, write something for the CPM to define it even more.
- Article 8 Officers and Chief Executive Officer 8.5 Add "treasurer" to sign checks.
- Article 10 Miscellaneous 10.5 Clarify definitions of "books, records and papers" to spell out better

Added Items to the Bylaws – Make GVR Board and Membership aware:

- Added: Article 1 Definitions 1.11 Master Deed Restriction.
- Added: Article 1 Definitions 1.12 Owner.
- Added compilation of items already included in Bylaws <u>not new</u>: Article 3 Membership and Use of Facilities – 3.2
- Not added, only defined more clearly Article 5 Membership Meetings And Voting 5.4
- Added from Statutes Article 7 Board Meetings 7.3.C

Questions for Legal:

- Article 4 Membership Fees And Dues 4.2 2nd sentence: **Should it read "expense of operating the recreational facilities of The Corporation" from the original Bylaws not "operating The Corporation"?**
- Article 7 Board Meetings 7.3.C: Should this be included in the Bylaws if it is already in the Statutes?
- Article 9 Committees 9.1.5: Restated Bylaws list Audit Committee under "Standing Committees" but original Bylaws (Article 8, Section 2.B) list under "Special Committees."
 Is this correct?

Suggestions:

- Make important items **bold** on Ballots (*i.e.*, *3.3.6 current member mailing address*).
- When post Amended & Restated Bylaws, put Q&A on website.
- Emphasize Restated Bylaws have no surprises in them.
- Place in February GVR Now!
- Future: Clean up "legalese" jargon throughout the Bylaws.
- List 3 reasons why the Restated Bylaws:
 - More readable and less legalese for the membership to understand;
 - Organized in a way to put common items together and not spread in multiple parts;
 - Organized in a way to make amendments easier to identify and not changing anything.

MOTION: Crothers / Seconded. Approve the Amended and Restated Bylaws of Green Valley Recreation, Inc. as amended to submit to the GVR Board for consideration for the 2018 ballot.
