- **1. Call to Order:** Chair Curtin called the meeting to order at 1:05pm MST.
- **2. Roll Call/Establish Quorum:** Roll was called and a quorum established. Chair Curtin announced that Lanny Hardy had resigned from the Committee.
- 3. Adopt Agenda: Motion to amend the agenda to remove Item 5b. Exhibit 1 Member Conduct. C. Sieck/seconded. Passed unanimously.
- 4. Minutes: Motion to approve the minutes of the Regular Meeting of October 14, 2019. P. Reynolds/seconded. Passed. Ayes 8, Abstain 1 (B. Northrup)
- 5. a. Bicycling Club Proposal Application was presented by Programs Coordinator Kathy Edwards. Discussion followed.

Motion to change C3 Insurance Line 2 to replace "they" with "commercial vendors." G. Vanderhoof/seconded. Passed unanimously.

<u>CPM Section VIII GVR Programs/Clubs, Subsection 2 GVR Clubs, Subsection 4 Liquor Policy</u>. The Broker recommended that this section include a "Clause of Conditions." In discussion the Committee, determining that they don't know what a "Clause of Conditions" is, asked to go back to the broker for an explanation and have it brought to the next meeting.

Motion to table this item until clarification comes from the broker. G. Vanderhoof/seconded. Passed unanimously.

C. Sieck presented on Section IV Facility Use, Subsection 3. Circulation of GVR-related Political Materials; GVR-related Surveys, Polls, Questionnaires.

Motion to add to Section IV Subsection A "This restriction shall also apply to candidate forums or town halls, except for those put on by the Nominations & Elections Committee." P. Reynolds/seconded.
