Upcoming eBlast announcement: Bylaws Subcommittee is working on the Amended and Restated Bylaws of Green Valley Recreation, Inc., to be forwarded to the Board Affairs Committee for approval.

Committee members decided to cancel the regular monthly meeting on November 3 and reschedule on November 9 at 9:30am, an "Open" meeting, to discuss ideas for a marketing plan to advertise to members the Amended and Restated Bylaws.
