

COMMUNITY SUPPORT

MASK RULE RESTATED

In a pool: If the exercise the member is doing would naturally result in a wet mask, they do not have to wear one. If the exercise the member is doing would not naturally result in a wet mask, they will have to wear one unless they are claiming an exemption. For some pool users, this might mean bringing a mask to wear while water walking, then removing it to swim or use a kick board. Masks do not eliminate the social distancing requirement. Both are expected.
